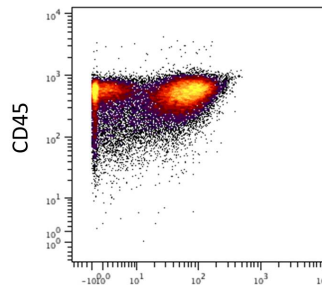

Technical Information

Validation: Each lot of conjugated antibody is quality control tested by CyTOF® analysis of stained cells using the appropriate positive and negative cell staining and/or activation controls.

Recommended Usage: The suggested use is 1 µl for up to 3 X 10⁶ live cells in 100 µl. It is recommended that the antibody be titrated for optimal performance for each of the desired applications.



PE (PE001) – 145Nd

Human PBMC stained with PE-anti-CD3(UCHT1) then detected with 145Nd-anti-PE (PE001). Plotted against 154Sm-anti-CD45 (HI30).

Description

The PE001 antibody reacts with both phycoerythrin (PE) alone and PE conjugated with antibody or streptavidin, as well as PE tandem dyes such as PE/Cy5, PE/Cy5.5 and PE/Cy7. The PE001 antibody does not quench PE fluorescence or react with mouse and human cells. The PE001 antibody can be used to amplify PE conjugated primary antibody signals in a secondary staining step.
